- A Grass Carp Permit MUST be obtained by NYS DEC prior to ordering. A copy of the permit MUST be submitted with your order, it will not be processed until it is received.
- Channel Catfish will reach approximately 2ft in length at maturity. They are semi-aggressive so be mindful if you plan to have them in swimming ponds and they will live approximately 8 years. We do not suggest this species for ponds less than a half-acre in size.
- Orders not picked up will not be held or refunded. They will also be subject to a cancellation fee.

****Bass Stocking Recommendations****

Bass: 100 fingerlings per surface acre (4-5" are slightly larger than a fingerling, so stocking can be cut by half) along with 500-600 minnows per surface acre.
